

Karate is aimed at the individual and every child will develop at his/her own pace. As a sport karate will teach you about fitness, discipline, commitment and instill confidence. It is also ideally suited in aiding a child in the development of skills needed to perform well at school, Your child will learn to co-ordinate his arms and legs by punching with left arm and kicking

right leg or vice versa. This will aid his concept of Laterality. Karate training teaches him to

move the two sides of his body symmetrically, or totally independent and orientates himself

in space by moving left, back, forward etc. This aids midline crossing, balance and position

in space. These concepts are extremely important in reading, writing and mathematics and

will therefore help to prepare your child for school readiness.

Karate is a unique sport, which in training constantly crosses the left and right side of the brain. The child's brain receives constant stimulation through the mid-line crossing techniques unique to karate training.
